Abstract : This completely revised 15th edition contains more than 30 new entries, including more than 20 new synthetic molecules. Reference dose values from the Environmental Protection Agency (EPA) and other sources have been included. References to Toxicological and Environmental Reviews have been further updated. The book also includes European Union Review reports, EPA Fact Sheets, WHO/Food and Agriculture Organization Health and Safety Guides, and Pesticide Data Sheets, and Inter-

Chemical Safety Cards. Analytical references have been updated to include the 6th edition of the AOAC International (formerly Association of Official Analytical Chemists) Compendex Plus. Methods have been extended to include methods in the Pesticide Analytical Manual. Toxicological and physico-chemical data have been revised in line with new data from manufacturers. Company names have been updated to reflect further changes in the industry. In total, there are now 908 main entries, an increase of 27 over the 5th edition. For each entry, information on nomenclature, physical chemistry, commercialization, applications (mode of action, uses and formulations), mammalian toxicology, ecotoxicology and environmental fate is provided. This book is a reliable reference for all those involved in pest, disease and weed control, whether researcher, regulator, adviser or front-line practitioner. A fully revised digital version of this publication, the e-Pesticide Manual Version 5.0, allows rapid searching of the data contained within this book and provides additional information, including manufacturer product names, and more information on superseded substances.
