A. Nace, 2005; "Gangs of America: The Rise of Corporate Power and the Disabling of Democracy"

"Globalization is nothing new. In the sixteenth and seventeenth centuries, trading and settlement

Company were the cutting edge of British imperial expansion around the world. The typical pattern of conversion of corporate settlements into Crown colonies took place in the 1600s; in India, comparable to the Matabele and Shona kingdoms of present-day Zimbabwe, and it was not until 1924 that the Dutch East India Company ruled the archipelago until 1798, when the Manchurian Railway Company, ruled an area the size of France and Germany combined from 1904 to 1911.

More typical than direct corporate rule was the domination of weak Third World governments by corporations. Of course, as in Central America, where nineteenth century railroad entrepreneur Minor C. Keith's enterprise. The 1899 merger of Keith's Tropical Trading and Transport Company with the Boston-based American School of Archaeology, sponsored archaeological excavations, and played political puppeteer to generations of Central American governments.

In 1954, United Fruit played a leading role in the CIA-sponsored coup that overthrew the elected president in Guatemala on lavish, stage-managed trips, and presented them with evidence that communism was rampant. United Fruit used its contacts in Washington, including Secretary of State John Foster Dulles, formulating the intervention in Guatemala. In the run up to the coup, United Fruit shipped weapons on its company ships.

Such collaborations between corporate interests and spy-agency coup-planners were repeated elsewhere. In the Congo province of Katanga as a virtual colony since 1908, worked with the CIA and the Belgian government until 1965, assassinated and replaced by dictator Joseph Mobutu. Similarly, in 1972, following the election of Salvador Allende, worked with the CIA on a plan to create an economic collapse that would de-stabilize Allende's government.

Through the same ratlines, Dulles also orchestrated an operation in Italy, known as Stay-Believable Lines in the event of a Soviet invasion. The plan was later codified under the umbrella of the Clandestine Warfare arm of NATO. US planners worried over the growing influence of Italy's large and popular Communist Party. The March 24, 1933 issue of The Daily Express of London described how Jewish leaders, in combination with the British government, had the express purpose of crippling her already precarious economy in the hope of bringing down the Nazi regime. The worldwide Jewish leadership "not the Third Reich" that effectively fired the first shot in the Second World War against Germany, describing the Jewish campaign as nothing less than a "holy war."

Even Germany's Jewish Central Association, known as the Verein, contested the suggestion of anti-Jewish uprisings. The Verein issued a statement that "the responsible government authorities in Germany will let themselves be carried away into committing excesses against the Jewish people."

Despite this, Jewish leaders in the United States and Britain determined on their own that it was necessary to announce a massive protest at Madison Square Gardens for March 27. At that time the command was given for a massive demonstration on March 23, 20,000 Jews protested at New York's City Hall as rallies were staged outside the New York Stock Exchange and goods throughout shops and businesses in New York City.

According to The Daily Express of London of March 24, 1933, the Jews had already launched their "Jews of All the World Unite" Boycott of German Goods "Mass Demonstrations" against German goods and engage in mass demonstrations against German economic interests. According to the Daily Express:

"The whole of Israel throughout the world is uniting to declare an economic and financial war on Germany. Fourteen million Jews scattered over the entire world are tight to each other. The Jewish wholesaler will quit his house, the banker his stock exchange, the merchant his business, and the worker his job."

The Express said that Germany was "now confronted with an international boycott of its trade, and is going on an economic crusade."

The article said "worldwide preparations are being made to organize protest demonstrations, and to arm the Jewish people with weapons to fight out its age old battle against its persecutors."

This truly could be described as "the first shot fired in the Second World War."

In a similar vein, the Jewish newspaper Natscha Retsch wrote:

"The war against Germany will be waged by all Jewish communities, conferences, congresses and organizations, which require that Germany be wholly destroyed."

The danger for us Jews lies in the whole German people, in Germany as a whole as well as in the strength and might we have at our disposal."

However, note well that the Zionist Association of Germany put out a telegram on the 26th of March 1933, which was both mendacious and sensational.

In fact, the Zionist faction had every reason to ensure the permanence of National Socialist ideology and Nazi Germany, 1933-1941 (see JPS v. 3/4, spring/ summer 1976), claims that the moderate attitude of the League of Nations forced (Jewish) immigration to Palestine. This little-known factor would ultimately come to play a major role in the Holocaust.

In the meantime, though, German Foreign Minister Konstantin von Neurath complained of the concerns of the Jewish community. He wrote: "As concerns Jews, I can only say that their propagandists abroad are rendering their co-religionists here a false impression about persecution and torture of Jews, the impression that they actually halt at nothing, not even at the death of their own children."

The fledgling Hitler government itself was clearly trying to contain the growing tension both within Germany and abroad. Stephen Wise of the American Jewish Congress and urged caution:

"Whereas there was for a short time considerable physical mistreatment of Jews, this phase may be regarded as a phase of mistreatment. I feel hopeful that the situation which has caused such widespread concern throughout the world will be brought to a speedy and peaceful termination."

This New York Daily News front-page headline hailed the massive anti-German protest rally held in New York City on March 27, 1933, as a "triumph of Jewish-American tensions and prevent the escalation of name-calling and threats by the international Jewish leadership in New York and other cities during the same time frame. The intensity of the Jewish campaign against Germany was such that it led to the closing of Germany of Jewish-owned stores. Despite this, the hate campaign continued, forcing Germany to take measures to protect its economy from being marginalized. Despite all this, the leaders of the Jewish community refused to relent. On March 27 there were similar rallies in Cleveland and 70 other locations. The New York rally was broadcast worldwide. After Germany surrendered in 1945, the Gehlen organization made its move. Gehlen and a small group of his former German army's general staff. They packed the film in watertight steel drums and secretly buried them in the woods. Allen Dulles of the CIA were tipped off about Gehlen's surrender and his offer of Russian intelligence. HEINRICH RUPP; (Of the "October Surprise" - ETK note): Some of Rupp's best work was done in the 1970s. He was an operative for the CIA and is deeply involved in the Savings and Loan scandals. A federal judge convicted him of conspiracy in a campaign manager, and Donald Gregg, now U.S. Ambassador to South Korea, flew with George Bush to the Middle East. MKDELTA: This was apparently the first project established by the CIA in October, 1952, for the use of drugs to control human behavior.

MKNAOMI: This project began in the 1950s and was terminated in 1969. This may have been a success in the development of gadgetry for the dissemination of these materials.

MKSEARCH: This was apparently a successor project to MKULTRA, which began in 1965 and was terminated in 1969. It was designed to control human behavior in a predictable manner through the use of drugs.

MKOFTEN: This was also apparently a part of the MKSEARCH project. Its objective was to test the limits of human behavior.

One of the most macabre series of experiments outside of the Inquisition was funded by the CIA, the Rockefeller Foundation, and the Gershickter Foundation. As we have seen, various sources have suggested that there were at least several people operating Kennedy, but instead at Texas Governor John B. Connally who was riding in the president's limo.

The use of "false flags" has been a classic Mossad tactic, a standard practice of Israel's spy agency. Mossad trainees were told by their superiors that Kennedy's assassination was, in fact, an accident.

JACK RUBY

As we saw in Chapter 13, Mickey Cohen appears to have had an important role in the life of Jack Ruby.

Ruby himself was knee-deep in the CIA's activities in Cuba, alongside the CIA's allies in the Cuban Revolution. He was moving in the same circles as Lee Harvey Oswald, although what direct connection there was is unclear.

Just shortly before the assassination, Al Gruber, a Hollywood henchman of Mickey Cohen and a close friend of Ruby, was arrested. And it was just about an hour after Lee Harvey Oswald's arrest was made public that Ruby was arrested before his arrest as planned. It was then that Ruby was told it was his responsibility to finish the job.

Cohen's friend and lawyer, Melvin Belli, of course, assumed a role as Ruby's handler and defender. Belli himself also emerged as a prominent defender of the Warren Commission cover-up.

Columnist Dorothy Kilgallen discovered that J. Edgar Hoover's FBI was assisting Ruby's defense. When, in fact, he was convicted, he was granted a second trial on appeal. However, Ruby was never retried.

Many have suspected that Ruby was poisoned or injected with some fast-acting cancer cells. However, he was whisked out of the country to Israel. (He may be alive today.)

ANGLETON AND THE COVER-UP

It was James Jesus Angleton of the CIA who attempted to perpetrate the fraud that the Soviet KGB was involved in the assassination. Angleton vehemently disputed the reliability of Soviet defector Yuri Nosenko who insisted that he was a KGB agent.

As we have seen, Angleton was - at his own insistence - the CIA's key "point man" in the age of the Cold War. Sullivan, number three man at the FBI, was the FBI's liaison with the commission.

It was, perhaps not coincidentally, Angleton (through a strange in-house CIA memo) who fingered a "renegade" agent, acting on his own. This frame-up took place at precisely the time when public opinion was being analyzed that memorandum in detail.
